When you use our website

Cookie Name	Purpose	Further Information
DYNSRV	Performance	This cookie helps improve performance of our website
_ga _gat _gld	Analytical/Performance	These cookies are part of Google Analytics and allow us to measure information about how visitors use our site. This includes identifying each unique user to our site and details of each page visited. _gat is used to limit the collection of analytics data on high traffic sites.
collect	Transfer	Google Analytics cookie used to send data about the visitor's device and behaviour. Tracks the visitor across devices and marketing channels.

The data we collect via Google Analytics is not used or shared by Google.

When you submit an enquiry via our website

We do not use the information you provide to make any automated decisions that might affect you.

Your rights as a data subject
